LEGISLATIVE UPDATE

As of July 1, counties sharing a watershed can form their own development commission with approval from the Natural Resources Commission

HOUSE ENROLLED ACT 1639

WHAT'S NEW?

Newly formed commissions would develop a flood damage reduction and drainage plan

Groups can receive authority
to perform drainage and flood
damage reduction activities, and
create water -quality improvement
plans with state approval

Commissions can partner with local cities and towns to boost efforts and funding support

Oversight Structure

ADVISORY COMMITTEE

The advisory committee consists of a member of the soil and water conservation district for each county that is a member of the commission.

NATURAL RESOURCE COMMISSION

The NRC decides whether to recognize a proposed watershed development commission

WATERSHED DEVELOPMENT COMMISSION BOARD

The board is the governing body over the watershed development commission and is responsible for establishing maximum assessment levels and can reduce the special assessment

WATERSHED DEVELOPMENT COMMISSION

Board Representation Overview

DNR

The director of the Department of Natural Resources or the director's designee

SURVEYOR

The county surveyor from each of the commission member counties

COUNTY


Are presentative of each member county

CITY

An individual representing each second class city in each member county or, if there is no second class city, the most populous municipality in the member county

LOCAL FUNDING SUPPORT

The Kankakee River Basin and Yellow River Basin Development Commission's funding comes from the landowners encompassed in the watershed:



Under the new law, a commission can impose an annual special assessment against each taxable parcel of real property located in a member county and within the designated watershed
