

#### History

- Drainage Handbook published in 1996
  - Revised and republished in 1999.
- SEA 140-2024
  - Tasked ISDA to prepare and publish an updated version of the Drainage Handbook.
  - Created Indiana Drainage Handbook advisory board.





#### Steps Taken


- ISDA contracted with Christopher B.

- Conducted Survey.























#### Next Steps
