

Indiana Farm Bureau, Inc. 2017 Email Sweepstakes

OFFICIAL RULES: NO PURCHASE NECESSARY TO ENTER OR WIN. You have not won yet.

Eligibility and Sponsorship: This Indiana Farm Bureau, Inc. 2017 Voting Membership Sweepstakes ("Sweepstakes") is open only to legal residents of Indiana who are at least 18 years old at time of entry and Indiana Farm Bureau members in good standing. Other restrictions apply. Void where prohibited. Winners of any other Indiana Farm Bureau, Inc. Membership Sweepstakes in 2017 are ineligible to win. The sponsor is Indiana Farm Bureau, Inc. Limit one entry per email address. Entries received from any person or e-mail address in excess of the stated entry limit will be void.
