

## **Indiana Farm Bureau, Inc.**

### **District 9 Overall 2020 Membership Sweepstakes**

**OFFICIAL RULES:** NO PURCHASE NECESSARY TO ENTER OR WIN. You have not won yet.

**Eligibility and Sponsorship:** This Indiana Farm Bureau, Inc. District 9 Overall 2020 Membership Sweepstakes (“Sweepstakes”) is open only to legal residents of Indiana who are at least 18 years old at time of entry. In order to enter, you must volunteer in the Indiana Farm Bureau District 9 (District determinations are made by Indiana Farm Bureau, Inc.). Other restrictions apply. Void where prohibited. The sponsor is Indiana Farm Bureau, Inc. (“Sponsor”), 225 S. East St., P.O. Box 1290, Indianapolis, IN 46206-1290. Employees and district directors of Sponsor, its affiliates, subsidiaries, their immediate family members and any persons living in the same household, whether or not related, are not eligible to participate. The term “immediate family members” includes spouses, parents, and children, regardless of where they reside.

**Entry Period:** This Sweepstakes begins February 1, 2020 at 12:00 a.m. Eastern Time (ET) and ends September 30, 2020 at 4:30 p.m. (“Entry Period”). Entries must be received by or postmarked by September 29, 2020 and mailed to the home office of Indiana Farm Bureau, Inc., 225 S. East Street, P.O. Box 1290, Indianapolis, IN to be a valid entry.

**How to Enter:** During the Entry Period, there are 2 ways to enter.

A. During the Entry Period, sign up a new voting member on a completed membership application. The name listed in the “referred by” area of each completed membership application will be entered to win the grand prize. A completed membership application is an application for a new Indiana Farm Bureau, Inc. member which includes payment in full. Membership applications can be obtained through county Farm Bureau offices, Indiana Farm Bureau, Inc., and can be found at [www.infb.org](http://www.infb.org). The completed membership applications should be mailed to Indiana Farm Bureau, Inc., attn.: K. Rogers, P.O. Box 1290, Indianapolis, IN, 46206-1290. Alternatively, completed applications may be taken to a county Farm Bureau office with an email notification to [krogers@infb.org](mailto:krogers@infb.org) (NOTE: You must complete all required fields of the entry form with information that is valid on the date of the drawing to be eligible). A person receives one (1) entry for every new voting member he/she signs. A person must sign at least two (2) new voting members to be eligible for the drawing.

Or, B. Participate without signing up a new Indiana Farm Bureau member by sending a postcard to the Sponsor in care of Chelsea Poe. Please include first name, last name, street address, city, state, zip code, daytime and evening phone numbers, email address and date-of-birth. Must also reference the District 9 Overall 2020 Membership Sweepstakes on the postcard. Postcard entries must be received by 4:30 p.m. ET on September 29, 2020.

Limit one entry per email address and per person for postcard entries. Entries received from any person or e-mail address in excess of the stated entry limit will be void. Entries generated by any automated means and entries made by any means which subvert the

entry process will be void. Sponsor and its employees are not responsible for any entries submitted through unauthorized channels or for any incomplete, lost, late, stolen, postage-due, misdirected, mutilated, inaccurate, incomplete, garbled, delayed or illegible entries, memberships, payments and mail, all of which will be void. All entries become property of Sponsor and none will be acknowledged or returned. Sponsor and its employees are not responsible for failure to receive or record entries, memberships, or mail due to human processing errors or transmission or technical failures of any kind.

**Prizes:** There is one (1) prize. The prize is \$200. Prize average retail value is \$200. A total of one (1) prize will be awarded. The volunteer who writes the most new voting members during the Entry Period will win the prize. If there is a tie, the volunteer who writes the most new voting members first within the Entry Period will win.

**Drawings/Odds:** The winners will be selected on October 7, 2020 at the Sponsor's office in a random drawing from among all eligible entries collected during the Entry Period. You do not need to be present to win. All entries, regardless of the mode of entry, have an equal chance of winning. A person may only win one prize. Winners will be notified via phone call. If there is a dispute about the identity of an entrant, the prize will be awarded to the natural person to whom the phone number is assigned by the telephone service. If the initial winner is ineligible or does not claim the prize within four (4) days, the prize will be forfeited and another winner will be randomly drawn. The prize is non-transferable and no substitution or cash equivalent is permitted. Winners are solely responsible for any federal, state, and local taxes. Odds of winning will depend on the number of eligible entries received, according to the eligibility requirements in the Sweepstakes. Non-winning entries will not be eligible for subsequent drawings.
