

## **Indiana Farm Bureau, Inc. 2019 Popcorn Sweepstakes**

**OFFICIAL RULES:** NO PURCHASE NECESSARY TO ENTER OR WIN. You have not won yet.

**Eligibility and Sponsorship:** This Indiana Farm Bureau, Inc. 2019 Popcorn Sweepstakes (“Sweepstakes”) is open only to legal residents of Indiana who are at least 18 years old at time of entry. Other restrictions apply. Void where prohibited. The sponsor is Indiana Farm Bureau, Inc. (“Sponsor”), 225 S. East St., P.O. Box 1290, Indianapolis, IN 46206-1290. Employees and district directors of Sponsor, its affiliates, subsidiaries, their immediate family members and any persons living in the same household, whether or not related, are not eligible to participate. The term “immediate family members” includes spouses, parents and children, regardless of where they reside.

**Entry Period:** This Sweepstakes begins August 2, 2019 at 9:00 a.m. Eastern Time (ET) and ends August 18, 2019 at 7:00 p.m. (“Entry Period”). Entries must be received by August 19, 2019 and mailed to the home office of Indiana Farm Bureau, Inc., 225 S. East Street, P.O. Box 1290, Indianapolis, IN to be a valid entry.

**How to Enter:** During the Entry Period, there are 2 ways to enter.

A. During the Entry Period, visit the Farm Bureau building at the Indiana State Fairgrounds, 1202 E. 38<sup>th</sup> Street, Indianapolis, IN and fill out an entry form at the designated kiosks in the building. (NOTE: You must complete all required fields of the entry form with information that is valid on the date of the drawing to be eligible). **LIMIT ONE ENTRY PER PERSON.** Or, B. Participate without going to the Indiana State Fair by sending a postcard to the Sponsor in care of Chelsea Poe. Please include first name, last name, street address, city, state, zip code, daytime and evening phone numbers, email address and date-of-birth. Please also reference the Popcorn Sweepstakes on the postcard. Postcard entries must be received by 4:30 p.m. ET on August 19, 2019. **LIMIT ONE ENTRY PER PERSON.**

Limit one entry per email address and per person regardless of the mode of entry. Entries received from any person or e-mail address in excess of the stated entry limit will be void. Entries generated by any automated means and entries made by any means which subvert the entry process will be void. Sponsor and its employees are not responsible for any entries submitted through unauthorized channels or for any incomplete, lost, late, stolen, postage-due, misdirected, mutilated, inaccurate, incomplete, garbled, delayed or illegible entries, memberships, payments and mail, all of which will be void. All entries become property of Sponsor and none will be acknowledged or returned. Sponsor and its employees are not responsible for failure to receive or record entries, memberships, or mail due to human processing errors or transmission or technical failures of any kind.

**Prizes:** There is one (1) grand prize. The grand prize is four hundred (400) bags of microwavable popcorn. Prize average retail value is \$200. A total of one (1) prize will be awarded.

**Drawings/Odds:** The winners will be selected at 3:00 p.m. ET on August 22, 2019 at the Sponsor’s office in a random drawing from among all eligible entries collected during the Entry Period. You do not need to be present to win. All entries, regardless of the mode of entry, have an equal chance of winning. Winners will be notified via phone call. If there is a dispute about the identity of an entrant, the prize will be awarded to the natural person to whom the phone number is assigned by the telephone service. If the initial winner is ineligible or does not claim the prize within four (4) days, the prize will be forfeited and another winner will be randomly drawn. The prize is non-transferable and no substitution or cash equivalent is permitted.
